A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 710, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§710- Commission of an offense while released on bail;
- 5 penalty. (a) A person commits the offense of commission of an
- 6 offense while released on bail if the person commits a criminal
- 7 offense under any federal, state, or local law while released on
- 8 bail pursuant to chapter 804 or the laws of any other
- 9 jurisdiction.
- 10 (b) Commission of an offense while released on bail is a
- 11 class C felony."
- 12 SECTION 2. Section 804-7.2, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "§804-7.2 Violations of conditions of release on bail,
- 15 recognizance, or supervised release. (a) Upon verified
- 16 application by the prosecuting attorney alleging that a
- 17 defendant has intentionally violated the conditions of release
- 18 on bail, recognizance, or supervised release, the judicial



- 1 officer named in section 804-5 shall issue a warrant directing
- 2 the defendant be arrested and taken forthwith before the court
- 3 [+]of[+] record for hearing. A law enforcement officer having
- 4 reasonable grounds to believe that a released felony defendant
- 5 has violated the conditions of release on bail, recognizance, or
- 6 supervised release, may, where it would be impracticable to
- 7 secure a warrant, arrest the defendant and take the defendant
- 8 forthwith before the court of record.
- 9 (b) Any person committing a criminal offense under any
- 10 federal, state, or local law during the period of release on
- 11 bail shall be guilty of the crime of commission of an offense
- 12 while released on bail in accordance with section 710- ."
- 13 SECTION 3. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 4. This Act shall take effect upon its approval.
