A BILL FOR AN ACT

RELATING TO GREENWAYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Act 233, Session 2 Laws of Hawaii 2011, required the office of planning to develop 3 a plan to establish a statewide system of greenways and trails and to coordinate with and seek input from the department of 4 5 transportation, department of land and natural resources, and 6 the counties. The office of planning submitted its final 7 report, Establishment of a Statewide Greenways System for 8 Hawaii, to the legislature in December 2011. 9 The final report stated that the community, county and 10 state agencies, and nonprofit organizations have been 11 participating in various plans, studies, and initiatives related 12 to the establishment of trails, greenways, bike routes, parks, 13 and other projects. However, state agencies raised concerns 14 that while the State should facilitate coordination of greenways 15 and trails, none of the agencies felt it was appropriate for 16 their particular program to undertake the responsibility for planning and implementation. Counties raised concerns related **17**

to funding the projects as well as ongoing maintenance.
