# A BILL FOR AN ACT

RELATING TO STATE FINANCES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that the national and  
2 global economic crisis that began in the second half of 2008 has  
3 caused significant economic problems in numerous industries in  
4 the State. Difficult economic times and declining tax revenues  
5 resulted in significant budget cuts and a reduction of state  
6 government core services.

7           The reduction in services has jeopardized the safety net of  
8 basic human services, health, and education needs for Hawaii's  
9 residents and families. While all of Hawaii's residents have  
10 been affected by the situation, gap group families and families  
11 closest to the poverty line have been severely impacted.

12           The purpose of this Act is to appropriate moneys to support  
13 programs essential to education, public health, and public  
14 welfare and begin to repair the decimated safety net.

15           SECTION 2. There is appropriated out of the general  
16 revenues of the State of Hawaii the sum of \$114,467 or so much  
17 thereof as may be necessary for fiscal year 2012-2013 for  
18 respite services.



1 The sum appropriated shall be expended by the department of  
2 health for the purposes of this Act.

3 SECTION 3. There is appropriated out of the general  
4 revenues of the State of Hawaii the sum of \$3,000,000 or so much  
5 thereof as may be necessary for fiscal year 2012-2013 to  
6 supplement the healthy start program.

7 The sum appropriated shall be expended by the department of  
8 health for the purposes of this Act.

9 SECTION 4. There is appropriated out of the general  
10 revenues of the State of Hawaii the sum of \$285,000 or so much  
11 thereof as may be necessary for fiscal year 2012-2013 to provide  
12 funding for grants pursuant to chapter 42F, Hawaii Revised  
13 Statutes, to:

- 14 (1) Catholic Charities Hawaii for the Lanakila
- 15 Multi-Purpose Senior Center \$175,000;
- 16 (2) Moiliili Community Center for the
- 17 Moiliili Senior Center Program \$50,000; and
- 18 (3) Waikiki Community Center \$60,000.

19 The sum appropriated shall be expended by the department of  
20 health for the purposes of this Act.

21 SECTION 5. There is appropriated out of the general  
22 revenues of the State of Hawaii the sum of \$4,800,000 or so much



1 thereof as may be necessary for fiscal year 2012-2013 for the  
2 kupuna care program.

3 The sum appropriated shall be expended by the department of  
4 health for the purposes of this Act.

5 SECTION 6. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$1,400,000 or so much  
7 thereof as may be necessary for fiscal year 2012-2013 for the  
8 aging and disability resource center.

9 The sum appropriated shall be expended by the department of  
10 health for the purposes of this Act.

11 SECTION 7. There is appropriated out of the general  
12 revenues of the State of Hawaii the sum of \$1,500,000 or so much  
13 thereof as may be necessary for fiscal year 2012-2013 for the  
14 developmental disabilities medicaid waiver program.

15 The sum appropriated shall be expended by the department of  
16 health for the purposes of this Act.

17 SECTION 8. There is appropriated out of the general  
18 revenues of the State of Hawaii the sum of \$7,500,000 or so much  
19 thereof as may be necessary for fiscal year 2012-2013 for adult  
20 mental health services.

21 The sum appropriated shall be expended by the department of  
22 health for the purposes of this Act.



1 SECTION 9. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$150,000 or so much  
3 thereof as may be necessary for fiscal year 2012-2013 for the  
4 long-term adult supports and resources program.

5 The sum appropriated shall be expended by the department of  
6 health for the purposes of this Act.

7 SECTION 10. There is appropriated out of the general  
8 revenues of the State of Hawaii the sum of \$1,260,000 or so much  
9 thereof as may be necessary for fiscal year 2012-2013 for  
10 substance abuse treatment and prevention services for adults and  
11 adolescents.

12 The sum appropriated shall be expended by the department of  
13 health for the purposes of this Act.

14 SECTION 11. There is appropriated out of the general  
15 revenues of the State of Hawaii the sum of \$140,000 or so much  
16 thereof as may be necessary for fiscal year 2012-2013 to provide  
17 funding for grants pursuant to chapter 42F, Hawaii Revised  
18 Statutes, to the Coalition for a Drug-Free Hawaii for substance  
19 abuse prevention services to youth and their families in the  
20 Kapolei district.

21 The sum appropriated shall be expended by the department of  
22 health for the purposes of this Act.



1 SECTION 12. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$426,722 or so much  
3 thereof as may be necessary for fiscal year 2012-2013 for the  
4 healthy aging partnership program.

5 The sum appropriated shall be expended by the department of  
6 health for the purposes of this Act.

7 SECTION 13. There is appropriated out of the general  
8 revenues of the State of Hawaii the sum of \$332,000 or so much  
9 thereof as may be necessary for fiscal year 2012-2013 to provide  
10 funding for grants pursuant to chapter 42F, Hawaii Revised  
11 Statutes, to the Waianae District Comprehensive Health and  
12 Hospital Board, Inc., to support its emergency room services.

13 The sum appropriated shall be expended by the department of  
14 health for the purposes of this Act.

15 SECTION 14. There is appropriated out of the general  
16 revenues of the State of Hawaii the sum of \$270,000 or so much  
17 thereof as may be necessary for fiscal year 2012-2013 for  
18 HIV/AIDS related services.

19 The sum appropriated shall be expended by the department of  
20 health for the purposes of this Act.

21 SECTION 15. There is appropriated out of the general  
22 revenues of the State of Hawaii the sum of \$10,500,000 or so



1 much thereof as may be necessary for fiscal year 2012-2013 for  
2 health care services for individuals who are uninsured and  
3 underinsured at federally qualified health centers on the  
4 islands of Hawaii, Kauai, Maui, Lanai, Molokai, and Oahu.

5 The sum appropriated shall be expended by the department of  
6 health for the purposes of this Act.

7 SECTION 16. There is appropriated out of the general  
8 revenues of the State of Hawaii the sum of \$300,000 or so much  
9 thereof as may be necessary for fiscal year 2012-2013 to:

- 10 (1) Increase children's oral health services and
- 11 prevention services;
- 12 (2) Increase public awareness of oral health through
- 13 outreach and education programs; and
- 14 (3) Establish and implement an electronic system to track
- 15 data on children's dental health.

16 The sum appropriated shall be expended by the department of  
17 health for the purposes of this Act.

18 SECTION 17. There is appropriated out of the general  
19 revenues of the State of Hawaii the sum of \$500,000 or so much  
20 thereof as may be necessary for fiscal year 2012-2013 to provide  
21 funding for grants pursuant to chapter 42F, Hawaii Revised



1 Statutes, to Kokua Kalihi Valley (Comprehensive Family  
2 Services).

3 The sum appropriated shall be expended by the department of  
4 health for the purposes of this Act.

5 SECTION 18. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$180,000 or so much  
7 thereof as may be necessary for fiscal year 2012-2013 for  
8 services to pregnant women struggling with addiction.

9 The sum appropriated shall be expended by the department of  
10 health for the purposes of this Act.

11 SECTION 19. There is appropriated out of the general  
12 revenues of the State of Hawaii the sum of \$699,557 or so much  
13 thereof as may be necessary for fiscal year 2012-2013 for the  
14 baby S.A.F.E. (substance abuse free environment) program.

15 The sum appropriated shall be expended by the department of  
16 health for the purposes of this Act.

17 SECTION 20. There is appropriated out of the general  
18 revenues of the State of Hawaii the sum of \$110,000 or so much  
19 thereof as may be necessary for fiscal year 2012-2013 for fetal  
20 alcohol spectrum disorders.

21 The sum appropriated shall be expended by the department of  
22 health for the purposes of this Act.



1 SECTION 21. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$546,021 or so much  
3 thereof as may be necessary for fiscal year 2012-2013 for family  
4 planning services.

5 The sum appropriated shall be expended by the department of  
6 health for the purposes of this Act.

7 SECTION 22. There is appropriated out of the general  
8 revenues of the State of Hawaii the sum of \$94,229 or so much  
9 thereof as may be necessary for fiscal year 2012-2013 for  
10 perinatal health programs.

11 The sum appropriated shall be expended by the department of  
12 health for the purposes of this Act.

13 SECTION 23. There is appropriated out of the general  
14 revenues of the State of Hawaii the sum of \$436,596 or so much  
15 thereof as may be necessary for fiscal year 2012-2013 for the  
16 preschool developmental screening program.

17 The sum appropriated shall be expended by the department of  
18 health for the purposes of this Act.

19 SECTION 24. There is appropriated out of the general  
20 revenues of the State of Hawaii the sum of \$75,000 or so much  
21 thereof as may be necessary for fiscal year 2012-2013 to provide  
22 funding for grants pursuant to chapter 42F, Hawaii Revised





1 Statutes, to Planned Parenthood of Hawaii for statewide sexual  
2 health education.

3 The sum appropriated shall be expended by the department of  
4 health for the purposes of this Act.

5 SECTION 25. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$151,391 or so much  
7 thereof as may be necessary for fiscal year 2012-2013 to provide  
8 funding for grants pursuant to chapter 42F, Hawaii Revised  
9 Statutes, to Child and Family Service for family centers on the  
10 island of Kauai named Nana's House and Hale Ho'omaluu.

11 The sum appropriated shall be expended by the department of  
12 human services for the purposes of this Act.

13 SECTION 26. There is appropriated out of the general  
14 revenues of the State of Hawaii the sum of \$160,389 or so much  
15 thereof as may be necessary for fiscal year 2012-2013 to provide  
16 funding for grants pursuant to chapter 42F, Hawaii Revised  
17 Statutes, to Child and Family Service for permanency support  
18 services on the island of Oahu.

19 The sum appropriated shall be expended by the department of  
20 human services for the purposes of this Act.

21 SECTION 27. There is appropriated out of the general  
22 revenues of the State of Hawaii the sum of \$133,810 or so much



1 thereof as may be necessary for fiscal year 2012-2013 to provide  
2 funding for grants pursuant to chapter 42F, Hawaii Revised  
3 Statutes, to Child and Family Service for substance abuse  
4 counseling services on the island of Maui.

5 The sum appropriated shall be expended by the department of  
6 human services for the purposes of this Act.

7 SECTION 28. There is appropriated out of the general  
8 revenues of the State of Hawaii the sum of \$600,000 or so much  
9 thereof as may be necessary for fiscal year 2012-2013 for  
10 comprehensive counseling and support services statewide.

11 The sum appropriated shall be expended by the department of  
12 human services for the purposes of this Act.

13 SECTION 29. There is appropriated out of the general  
14 revenues of the State of Hawaii the sum of \$1,000,000 or so much  
15 thereof as may be necessary for fiscal year 2012-2013 for  
16 resource family recruitment, licensing, and training under the  
17 Hui Ho'omalau Consortium.

18 The sum appropriated shall be expended by the department of  
19 human services for the purposes of this Act.

20 SECTION 30. There is appropriated out of the general  
21 revenues of the State of Hawaii the sum of \$75,000 or so much



1 thereof as may be necessary for fiscal year 2012-2013 for the  
2 Waianae receiving home.

3 The sum appropriated shall be expended by the department of  
4 human services for the purposes of this Act.

5 SECTION 31. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$140,000 or so much  
7 thereof as may be necessary for fiscal year 2012-2013 for multi-  
8 disciplinary teams and psychological evaluations.

9 The sum appropriated shall be expended by the department of  
10 human services for the purposes of this Act.

11 SECTION 32. There is appropriated out of the general  
12 revenues of the State of Hawaii the sum of \$230,000 or so much  
13 thereof as may be necessary for fiscal year 2012-2013 for ohana  
14 conferencing.

15 The sum appropriated shall be expended by the department of  
16 human services for the purposes of this Act.

17 SECTION 33. There is appropriated out of the general  
18 revenues of the State of Hawaii the sum of \$9,410 or so much  
19 thereof as may be necessary for fiscal year 2012-2013 for the  
20 interstate compact for the placement of children.

21 The sum appropriated shall be expended by the department of  
22 human services for the purposes of this Act.



1 SECTION 34. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$3,000,000 or so much  
3 thereof as may be necessary for fiscal year 2012-2013 for family  
4 strengthening services.

5 The sum appropriated shall be expended by the department of  
6 human services for the purposes of this Act.

7 SECTION 35. There is appropriated out of the general  
8 revenues of the State of Hawaii the sum of \$400,000 or so much  
9 thereof as may be necessary for fiscal year 2012-2013 for  
10 parenting skills training.

11 The sum appropriated shall be expended by the department of  
12 human services for the purposes of this Act.

13 SECTION 36. There is appropriated out of the general  
14 revenues of the State of Hawaii the sum of \$800,000 or so much  
15 thereof as may be necessary for fiscal year 2012-2013 for teen  
16 pregnancy prevention.

17 The sum appropriated shall be expended by the department of  
18 human services for the purposes of this Act.

19 SECTION 37. There is appropriated out of the general  
20 revenues of the State of Hawaii the sum of \$200,000 or so much  
21 thereof as may be necessary for fiscal year 2012-2013 to provide  
22 funding for grants pursuant to chapter 42F, Hawaii Revised



1 Statutes, to the Blueprint for Change for neighborhood place  
2 walk-in centers.

3 The sum appropriated shall be expended by the department of  
4 human services for the purposes of this Act.

5 SECTION 38. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$550,000 or so much  
7 thereof as may be necessary for fiscal year 2012-2013 to provide  
8 funding for grants pursuant to chapter 42F, Hawaii Revised  
9 Statutes, to the Hawaii Primary Care Association for the Hawaii  
10 immigrant health initiative program provided at federally  
11 qualified health centers.

12 The sum appropriated shall be expended by the department of  
13 human services for the purposes of this Act.

14 SECTION 39. There is appropriated out of the general  
15 revenues of the State of Hawaii the sum of \$450,000 or so much  
16 thereof as may be necessary for fiscal year 2012-2013 to provide  
17 funding for grants pursuant to chapter 42F, Hawaii Revised  
18 Statutes, to Susannah Wesley Community Center for afterschool  
19 and teen programs.

20 The sum appropriated shall be expended by the department of  
21 human services for the purposes of this Act.



1 SECTION 40. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$210,000 or so much  
3 thereof as may be necessary for fiscal year 2012-2013 to provide  
4 funding for grants pursuant to chapter 42F, Hawaii Revised  
5 Statutes, to Hale Mahaolu for personal care services.

6 The sum appropriated shall be expended by the department of  
7 human services for the purposes of this Act.

8 SECTION 41. There is appropriated out of the general  
9 revenues of the State of Hawaii the sum of \$200,000 or so much  
10 thereof as may be necessary for fiscal year 2012-2013 for the  
11 shelter plus care program.

12 The sum appropriated shall be expended by the department of  
13 human services for the purposes of this Act.

14 SECTION 42. There is appropriated out of the general  
15 revenues of the State of Hawaii the sum of \$1,900,000 or so much  
16 thereof as may be necessary for fiscal year 2012-2013 to provide  
17 funding for grants pursuant to chapter 42F, Hawaii Revised  
18 Statutes, to the Hawaii Primary Care Association for adult  
19 dental care provided at federally qualified health centers;  
20 provided that the funds shall not be used for any other purpose.  
21 The governor is authorized to utilize enhanced federal medical



1 assistance percentages funds to offset the amount appropriated;  
2 provided that the total amount shall not exceed \$2,000,000.

3 The sum appropriated shall be expended by the department of  
4 human services for the purposes of this Act.

5 SECTION 43. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$100,000 or so much  
7 thereof as may be necessary for fiscal year 2012-2013 for Maui  
8 community college, university of Hawaii, for the adult dental  
9 care program.

10 The sum appropriated shall be expended by the department of  
11 human services for the purposes of this Act.

12 SECTION 44. There is appropriated out of the general  
13 revenues of the State of Hawaii the sum of \$838,782 or so much  
14 thereof as may be necessary for fiscal year 2012-2013 to match  
15 the federal medicaid allowance allocated to the State for adult  
16 vision services.

17 The sum appropriated shall be expended by the department of  
18 human services for the purposes of this Act.

19 SECTION 45. There is appropriated out of the general  
20 revenues of the State of Hawaii the sum of \$30,000 or so much  
21 thereof as may be necessary for fiscal year 2012-2013 for



1 outstationed eligibility worker services provided at federally  
2 qualified health centers.

3 The sum appropriated shall be expended by the department  
4 human services for the purposes of this Act.

5 SECTION 46. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$80,000 or so much  
7 thereof as may be necessary for fiscal year 2012-2013 to provide  
8 funding for grants pursuant to chapter 42F, Hawaii Revised  
9 Statutes, to the Hawaii Primary Care Association for outreach  
10 services provided at federally qualified health centers.

11 The sum appropriated shall be expended by the department of  
12 human services for the purposes of this Act.

13 SECTION 47. There is appropriated out of the general  
14 revenues of the State of Hawaii the sum of \$44,636 or so much  
15 thereof as may be necessary for fiscal year 2012-2013 to provide  
16 funding for grants pursuant to chapter 42F, Hawaii Revised  
17 Statutes, to the Hawaii Primary Care Association for outreach  
18 services to locate uninsured children for services at federally  
19 qualified health centers.

20 The sum appropriated shall be expended by the department of  
21 human services for the purposes of this Act.





1 SECTION 48. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$274,111 or so much  
3 thereof as may be necessary for fiscal year 2012-2013 to provide  
4 funding for grants pursuant to chapter 42F, Hawaii Revised  
5 Statutes, to Adult Friends for Youth for youth gang prevention  
6 and intervention services.

7 The sum appropriated shall be expended by the department of  
8 human services for the purposes of this Act.

9 SECTION 49. There is appropriated out of the general  
10 revenues of the State of Hawaii the sum of \$500,000 or so much  
11 thereof as may be necessary for fiscal year 2012-2013 to the  
12 office of youth services for a youth gang response system.

13 The sum appropriated shall be expended by the department of  
14 human services for the purposes of this Act.

15 SECTION 50. There is appropriated out of the general  
16 revenues of the State of Hawaii the sum of \$800,000 or so much  
17 thereof as may be necessary for fiscal year 2012-2013 for child  
18 care subsidies.

19 The sum appropriated shall be expended by the department of  
20 human services for the purposes of this Act.

21 SECTION 51. There is appropriated out of the general  
22 revenues of the State of Hawaii the sum of \$1,000,000 or so much



1 thereof as may be necessary for fiscal year 2012-2013 to the  
2 united peer learning integrated new knowledge program for  
3 statewide non-school hour programs.

4 The sum appropriated shall be expended by the office of  
5 youth services of the department of human services for the  
6 purposes of this Act.

7 SECTION 52. There is appropriated out of the general  
8 revenues of the State of Hawaii the sum of \$450,000 or so much  
9 thereof as may be necessary for fiscal year 2012-2013 to provide  
10 funding for grants pursuant to chapter 42F, Hawaii Revised  
11 Statutes, to Hawaii Centers for Independent Living for statewide  
12 independent living services.

13 The sum appropriated shall be expended by the department of  
14 human services for the purposes of this Act.

15 SECTION 53. There is appropriated out of the general  
16 revenues of the State of Hawaii the sum of \$600,000 or so much  
17 thereof as may be necessary for fiscal year 2012-2013 to provide  
18 funding for grants pursuant to chapter 42F, Hawaii Revised  
19 Statutes, to the Partners in Development Foundation to:

- 20 (1) Provide comprehensive family training (early  
21 childhood, parent, adult education, and intensive  
22 child-caregiver activities) and transitional services



1 to sheltered and unsheltered homeless families on the  
2 leeward coast of Oahu;

3 (2) Offer early screening, assessment, and referral  
4 services for homeless children from birth to age five;  
5 and

6 (3) Prepare homeless children for kindergarten by  
7 providing developmentally appropriate social,  
8 emotional, and cognitive activities in a child-  
9 caregiver interactive learning environment.

10 The sum appropriated shall be expended by the department of  
11 human services for the purposes of this Act.

12 SECTION 54. There is appropriated out of the general  
13 revenues of the State of Hawaii the sum of \$2,000,000 or so much  
14 thereof as may be necessary for fiscal year 2012-2013 for the  
15 homeless programs office of the department of human services, to  
16 assist homeless and at-risk individuals and families with  
17 housing placement, health, education, employment, and other  
18 support services.

19 The sum appropriated shall be expended by the department of  
20 human services for the purposes of this Act.

21 SECTION 55. There is appropriated out of the general  
22 revenues of the State of Hawaii the sum of \$1,500,000 or so much



1 thereof as may be necessary for fiscal year 2012-2013 for a  
2 rental assistance program, also known as a shallow subsidy  
3 program, for sheltered homeless who are ready to rent permanent  
4 housing in order to obtain and maintain permanent housing;  
5 provided that the maximum subsidy shall be \$300 per month after  
6 households pay a minimum of thirty per cent of their adjusted  
7 income for rent.

8 The sum appropriated shall be expended by the department of  
9 human services for the purposes of this Act.

10 SECTION 56. There is appropriated out of the general  
11 revenues of the State of Hawaii the sum of \$3,200,000 or so much  
12 thereof as may be necessary for fiscal year 2012-2013 for the  
13 preschool open doors program.

14 The sum appropriated shall be expended by the department of  
15 human services for the purposes of this Act.

16 SECTION 57. There is appropriated out of the general  
17 revenues of the State of Hawaii the sum of \$150,000 or so much  
18 thereof as may be necessary for fiscal year 2012-2013 to provide  
19 funding for grants pursuant to chapter 42F, Hawaii Revised  
20 Statutes, to The Children's Alliance of Hawaii, Inc., to provide  
21 child sex assault services.



1           The sum appropriated shall be expended by the department of  
2 human services for the purposes of this Act.

3           SECTION 58. There is appropriated out of the general  
4 revenues of the State of Hawaii the sum of \$350,000 or so much  
5 thereof as may be necessary for fiscal year 2012-2013 for  
6 education and prevention related to children exposed to domestic  
7 violence and dating violence.

8           The sum appropriated shall be expended by the department of  
9 human services for the purposes of this Act.

10          SECTION 59. There is appropriated out of the general  
11 revenues of the State of Hawaii the sum of \$1,250,000 or so much  
12 thereof as may be necessary for fiscal year 2012-2013 for  
13 auxiliary necessary staffing for domestic violence shelters.

14          The sum appropriated shall be expended by the department of  
15 human services for the purposes of this Act.

16          SECTION 60. There is appropriated out of the general  
17 revenues of the State of Hawaii the sum of \$150,000 or so much  
18 thereof as may be necessary for fiscal year 2012-2013 to provide  
19 funding for grants pursuant to chapter 42F, Hawaii Revised  
20 Statutes, to Catholic Charities Hawaii to provide intra-familial  
21 sex assault services.



1 The sum appropriated shall be expended by the judiciary for  
2 the purposes of this Act.

3 SECTION 61. There is appropriated out of the general  
4 revenues of the State of Hawaii the sum of \$975,000 or so much  
5 thereof as may be necessary for fiscal year 2012-2013 for  
6 domestic violence services.

7 The sum appropriated shall be expended by the judiciary for  
8 the purposes of this Act.

9 SECTION 62. There is appropriated out of the general  
10 revenues of the State of Hawaii the sum of \$570,000 or so much  
11 thereof as may be necessary for fiscal year 2012-2013 to provide  
12 funding for grants pursuant to chapter 42F, Hawaii Revised  
13 Statutes, to Domestic Violence Action Center to provide  
14 specialized legal and advocacy services for victims of domestic  
15 violence.

16 The sum appropriated shall be expended by the judiciary for  
17 the purposes of this Act.

18 SECTION 63. There is appropriated out of the general  
19 revenues of the State of Hawaii the sum of \$1,382,000 or so much  
20 thereof as may be necessary for fiscal year 2012-2013 to provide  
21 funding for grants pursuant to chapter 42F, Hawaii Revised  
22 Statutes, to:



1 (1) Volunteer Legal Services Hawaii to provide pro bono

5 (3) The Hawaii Family Law Clinic to provide services to  
6 obtain temporary restraining orders;

7 and to be distributed as follows:

8 (1) Volunteer Legal Services Hawaii \$300,000;

9 (2) Legal Aid Society of Hawaii \$800,000; and

10 (3) Hawaii Family Law Clinic \$282,000.

11 The sum appropriated shall be expended by the judiciary for  
12 the purposes of this Act.

13 SECTION 64. There is appropriated out of the general
