## HOUSE CONCURRENT RESOLUTION

CONVENING AN AGRICULTURE POLICY TASK FORCE TO REVIEW AGRICULTURAL POLICIES FROM OTHER STATES IN PROVIDING FOR HAWAII'S AGRICULTURE INDUSTRY.

1 WHEREAS, the local agriculture industry is highly 2 significant to Hawaii's economy and the public's well-being; and 3 WHEREAS, food safety, costs, and availability; clean air; 4 5 and clean water are issues of public concern that should be considered in expanding the State's agricultural industry; and 6 7 8 WHEREAS, Hawaii is not unique in its need to encourage the 9 growth of its local agriculture industry, and other states may offer examples of agriculture policies that preserve competition 10 11 and safety; and 12 13 WHEREAS, immediate support for the State's agriculture industry would improve food self-sufficiency and security; 14 increase sustainability, job opportunities, and Hawaii 15 agricultural exports; and contribute to the diversification of 16 the State's economy; now, therefore, 17 18 BE IT RESOLVED by the House of Representatives of the 19 Twenty-sixth Legislature of the State of Hawaii, Regular Session 20 of 2012, the Senate concurring, that the Chairperson of the 21 22 Board of Agriculture is requested to convene an agriculture 23 policy task force to review agriculture policies from other states that may be effective in Hawaii to assist the development 24 of the local agriculture industry; and 25 26 27 BE IT FURTHER RESOLVED that the task force is requested to include the following members or the member's designee: 28 29
