
HOUSE CONCURRENT RESOLUTION

URGING THE HAWAII PUBLIC HOUSING AUTHORITY TO ENTER INTO PUBLIC-PRIVATE PARTNERSHIPS TO MODERNIZE DILAPIDATED FEDERAL PUBLIC HOUSING PROJECTS.

1 WHEREAS, many public housing projects owned and operated by
2 the Hawaii Public Housing Authority ("Authority") are in poor
3 physical condition and require repairs and modernization; and
4

5 WHEREAS, the Authority has reported that as many as four
6 hundred to six hundred units cannot be rented out due to
7 uninhabitable conditions; and
8

9 WHEREAS, during the 2010 federal inspections, eleven out of
10 the sixty-five federal public housing projects failed to pass,
11 receiving a score of fifty-nine or below out of a possible one
12 hundred, and approximately one-third of the Authority's federal
13 public housing projects received a score of sixty-nine or below;
14 and

16 WHEREAS, the use of a public-private partnership to
17 modernize the Kuhio Park Terrace federal public housing project
18 has demonstrated that such partnerships can be successful in
19 rapidly transforming the physical condition of a project for its
20 residents; and
21

22 WHEREAS, the United States Department of Housing and Urban
23 Development's ("HUD") Capital Fund Financing Program allows
24 public housing authorities to borrow against their future annual
25 allocations of capital funds to help finance modernization of
26 federal public housing projects; and
27

28 WHEREAS, HUD's Rental Assistance Demonstration Program
29 would allow public housing authorities to convert federal public
30 housing properties into either Section 8 project-based voucher
31 projects or project-based rental assistance contract projects,
32 thereby allowing them to leverage private investment with

1 Section 8 subsidies to address current repair and redevelopment
2 needs and permit future recapitalization of the properties; and
3

4 WHEREAS, under these HUD programs, the Authority is able to
5 enter into public-private partnerships and may leverage its HUD
6 subsidies with private investments to finance project capital
7 improvements; now, therefore,
8

9 BE IT RESOLVED by the House of Representatives of the
10 Twenty-sixth Legislature of the State of Hawaii, Regular Session
11 of 2012, the Senate concurring, that the Hawaii Public Housing
12 Authority is urged to pursue public-private partnerships to
13 modernize its federal public housing inventory; and
14

15 BE IT FURTHER RESOLVED that certified copies of this
16 Concurrent Resolution be transmitted to the Executive Director
17 of the Hawaii Public Housing Authority and the Chairperson of
18 the Board of Directors of the Hawaii Public Housing Authority.
