
HOUSE RESOLUTION

HONORING THE MEMBERS OF WORLD WINGS INTERNATIONAL - HAWAII
CHAPTER FOR THEIR DEDICATION TO PRESERVING PAN AMERICAN
WORLD AIRWAYS' EXCEPTIONAL HISTORY, FOR PROMOTING HAWAII,
AND FOR THEIR PHILANTHROPIC CONTRIBUTIONS TO HAWAII.

1 WHEREAS, World Wings International, Inc., a philanthropic
2 organization of former flight attendants of Pan American World
3 Airways, officially chartered in 1959, is an international
4 organization with 2,400 members in 30 chapters in the United
5 States, Europe, and Japan; and

7 WHEREAS, Pan American World Airways was a world leader in
8 aviation during its heyday, and World Wings International
9 supports activities that preserve Pan American World Airways'
10 exceptional history and the many contributions its flight
11 attendants made to creating "The World's Most Experienced
12 Airline"; and

14 WHEREAS, although World Wings International adopted CARE in
15 1994 as its official charity, each chapter of World Wings
16 International supports its own local charities, including
17 schools, hospitals, childcare centers, shelters, food banks,
18 medical research, and other charitable causes; and

20 WHEREAS, WORLD WINGS INTERNATIONAL - HAWAII CHAPTER
21 received its charter in 1965 and presently has 92 members; and

23 WHEREAS, since its inception, WORLD WINGS INTERNATIONAL -
24 HAWAII CHAPTER has donated over \$150,000 to various charities in
25 Hawaii, including Pohukaina School, the Special Olympics,
26 Pacific Foundation for Cancer Research, and Easter Seals, and,
27 since 1990, St. Francis Hospice; and



1 WHEREAS, St. Francis Hospice is Hawaii's first and largest
 2 hospice program, providing hospice care services to terminally
 3 ill patients and their families in a home setting, and operates
 4 two inpatient facilities, the Sister Maureen Keleher Center in
 5 Nuuanu and the Maurice J. Sullivan Family Hospice Center in Ewa
 6 Beach; now, therefore,

 9 Twenty-sixth Legislature of the State of Hawaii, Regular Session
 10 of 2012, that this body hereby honors and commends the members
 11 of WORLD WINGS INTERNATIONAL - HAWAII CHAPTER for their
 12 dedication to preserving Pan American World Airways' exceptional
 13 history, the many contributions its flight attendants have made
 14 to promoting Hawaii, and for its philanthropic contributions to
 15 Hawaii's people, and extends to all of its members a sincere
