MAKING AN APPROPRIATION FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

SECTION 1. There are appropriated or authorized from the sources of funding indicated below to program planning, analysis, and budgeting (BUF 101) the following sums or so much thereof as may be necessary to fund for fiscal biennium 2011-2013, the Hawaii employer-union health benefits trust fund costs in the agreements negotiated with the exclusive bargaining representatives of collective bargaining unit (6):
