#### A BILL FOR AN ACT

RELATING TO FELONIES FOR WHICH CRIMINAL CHARGES MAY BE INSTITUTED BY WRITTEN INFORMATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:
