### A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that students who do not
- 2 hold a lawful immigration status encounter extreme hardship
- 3 attending public institutions of higher education in the State,
- 4 as they must pay a nonresident tuition and fee differential and
- 5 are not eliqible for financial assistance. Many of these
- 6 students have lived in the State for the majority of their lives
- 7 and have thrived socially and academically. In addition, many
- 8 are unaware of their immigration status until they apply for
- 9 admission to institutions of higher education.
- 10 The legislature further finds that permitting these
- 11 students to access higher education with the same benefits as
- 12 resident citizens is in the public interest as it will allow
- 13 them to fully realize their potential as productive members of
- 14 society.
- 15 Under the federal Immigration and Nationality Act, states
- 16 have the authority to grant state and local public benefits to
- 17 residents who do not have lawful immigration status. The
- 18 purpose of this Act, therefore, is to assist these students in



- 1 accessing higher education by extending eligibility to
- 2 participate in state financial aid programs and exempting from
- 3 the nonresident tuition and fee differential students who meet
- 4 specified criteria.
- 5 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- 6 amended by adding a new section to be appropriately designated
- 7 and to read as follows:
- 8 "§304A- Resident noncitizens; tuition; financial aid.
- 9 (a) Students who are exempt from the nonresident tuition and
- 10 fee differential under section 304A-502(c) shall be eligible to
- 11 apply for and participate in all student financial aid programs
- 12 administered by the university to the full extent permitted
- 13 under federal law.
- 14 (b) The board of regents shall adopt rules and procedures
- 15 to implement subsection (a).
- 16 (c) If a state court finds that subsection (a), or any
- 17 similar rule adopted by the board of regents, is unlawful, the
- 18 court may order, as equitable relief, that the administering
- 19 entity that is the subject of the lawsuit terminate any waiver
- 20 awarded under that statute or rule, but no money damages,
- 21 tuition refund or waiver, or other retroactive relief may be
- 22 awarded. In any action in which the court finds that subsection

1 (a), or any similar rule adopted by the board of regents is 2 unlawful, the university shall be immune from the imposition of 3 any award of money damages, tuition refund or waiver, or other 4 retroactive relief." 5 SECTION 3. Section 304A-502, Hawaii Revised Statutes, is 6 amended to read as follows: 7 "[+] §304A-502[+] Power of regents to grant tuition 8 waivers. (a) The board of regents, or its designated 9 representatives, is authorized to grant, modify, or suspend 10 tuition waivers. 11 (b) The board may: 12 (1) Waive entirely or reduce the tuition fee or any of the 13 other fees for graduate teaching and research 14 assistants: 15 (2) Enter into agreements with government and university 16 officials of any other state or foreign country to 17 provide for reciprocal waiver of the nonresident 18 tuition and fee differential; Waive the nonresident tuition and fee differential for 19 (3) 20 selected students from Pacific and Asian jurisdictions 21 when their presence would be beneficial to the

university or the State;

9	SECTION 4. Statutory material to be repealed is bracketed
10	and stricken. New statutory material is underscored.
11	SECTION 5. This Act shall take effect upon its approval.
