A BILL FOR AN ACT

RELATING TO PUBLICATION OF NOTICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. It is anticipated the State will spend over 2 \$1,000,000 annually by 2013 to publish its notices in 3 newspapers. During these times of economic downturn and decreased tax revenues, it is imperative that the State and the 4 5 counties look for ways to trim their costs. 6 The purpose of this Act is to allow state and county 7 agencies to publish their notices by electronic or online 8 publication. 9 SECTION 2. Section 1-28.5, Hawaii Revised Statutes, is amended as follows: 10 11 1. By amending subsection (a) to read: 12 "(a) Notwithstanding any other statute, law, charter 13 provision, ordinance, or rule to the contrary, whenever a 14 government agency is required to give public notice or to 15 publish notice, the notice shall be given only as follows: 16 (1) For statewide publication: 17 (A) In a daily or weekly publication of statewide

12	2. By amending subsection (c) to read:
13	"(c) Whenever a public notice is published [in a newspaper
14	or other publication] as described in subsection (a), proof of
15	the publication shall be the affidavit of the printer,
16	publisher, principal clerk, or business manager of the newspaper
17	or other publication $[\frac{or}{.}]$ of the designated agent of the group
18	that published the notice[-], or of the designated
19	representative of the agency whose notice is published
20	electronically or online."
21	SECTION 3. Statutory material to be repealed is bracketed
22	and stricken. New statutory material is underscored.
