# A BILL FOR AN ACT

RELATING TO THE STATE CODE OF ETHICS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the public interest
- 2 is disserved when experts or persons who possess the knowledge
- 3 that could benefit the State, decline to serve or are foreclosed
- 4 from serving as members of advisory groups convened solely for
- 5 the purpose of sharing knowledge or experiences, making
- 6 recommendations, or commenting on proposed courses of action
- 7 because they would otherwise stand to gain financially, from the
- 8 advice or comments they provide, or the recommendations they may
- 9 make.
- 10 This Act amends the definition of "employee" in part II of
- 11 chapter 84, Hawaii Revised Statutes, to exempt from that
- 12 definition and the provisions of the State's Code of Ethics,
- 13 persons who serve on advisory or working groups that are
- 14 convened solely for the purpose of commenting, sharing technical
- 15 knowledge or experience, or formulating recommendations.
- The purpose of this Act is to allow persons with knowledge
- 17 and expertise the State needs to serve as members of state
- 18 advisory or working groups without being foreclosed by the

- 2 State's code of ethics.
- 3 SECTION 2. Section 84-3, Hawaii Revised Statutes, is
- 4 amended by amending the definition of "employee" to read as
- 5 follows:"
- 6 ""Employee" means any nominated, appointed, or elected
- 7 officer or employee of the State, including members of boards,
- 8 commissions, and committees, and employees under contract to the
- 9 State or of the constitutional convention, but excluding
- 10 legislators, delegates to the constitutional convention,
- 11 justices [and], judges [-], and members of groups convened by a
- 12 statute or resolution, an executive order or proclamation, or
- 13 the invitation of the legislature, the governor, or another
- 14 state officer, solely for the purpose of providing advice or
- 15 comments to, or formulating recommendations for, the
- 16 legislature, the governor, or a state department, agency, or
- 17 officer."
- 18 SECTION 3. Statutory material to be repealed is bracketed
- 19 and stricken. New statutory material is underscored.
- 20 SECTION 4. This Act shall take effect upon its approval.
