A BILL FOR AN ACT

RELATING TO CEMETERY AND FUNERAL TRUSTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 441-22.5, Hawaii Revised Statutes, is				
2	amended to read as follows:				
3	"§441-22.5 Mortuary, cemetery, or pre-need funeral				
4	authority; disclosure requirements. (a) No cemetery property,				
5	interment services, funeral services, and related commodities				
6	shall be sold unless the mortuary, cemetery, or pre-need funeral				
7	authority first satisfies the requirements stated in section				
8	441-22.6.				
9	(b) Every cemetery or pre-need funeral authority shall be				
10	required to provide to the purchaser of cemetery property, pre-				
11	need interment, or pre-need funeral services and related				
12	commodities a written contract which shall contain the following				
13	disclosures:				
14	(1) The names and addresses of the cemetery or pre-need				
15	funeral authority, purchaser, and contract				
16	beneficiary, if the beneficiary is someone other than				
17	the purchaser;				

1	(2)	A clear and concise itemized statement of the
2		property, including, for cemetery property, the
3		location of the plot, crypt, or niche by its unique
4		identifier, and any services and related commodities
5		to be supplied or not supplied and by whom,
6	÷	particularly if the authority is not to be the
7		provider under the terms of the contract;
8	(3)	The purchase price of each item of property, services,
9		and related commodities to be supplied, the total
10		purchase price, and how the total purchase price is
11		payable, including any credit terms, if applicable;
12		provided that, pursuant to section 441-22.7,
13		disclosure shall also be made that further additional
14		charges or fees for perpetual care subsequent to the
15		execution of the contract are prohibited for any
16		purpose and on any occasion, except for reasonable
17		fees related to the administrative costs of
18		transferring ownership rights, including the cost of
19		research, document and file preparation, photocopying,
20		notary fees, records transfer and storage, and any
21		other costs directly related to the transfer of
22		ownership rights;

2	(5)	The	basis on which funds are to be deposited in trust

4		(A)	The name and address of the trustee; provided
5			that the disclosure shall not preclude the
6			cemetery or pre-need funeral authority from

8		(B)	The percentage of the contract price for
9			trustable items to be placed in trust; provided
10			that the percentage shall be no less than sevents
11			per cent;
12		(C)	The percentage of the contract price for
13			trustable items that the cemetery or pre-need
14			funeral authority will retain and not deposit
15			into the trust; provided that the percentage
16			shall not be more than thirty per cent; and
17		(D)	Where a portion of the contract price relates to
18			property, services, or related commodities that
19			are not trustable items, a clear description of
20			what those non-trustable items are;
21	(6)	The	refund, cancellation, and default provisions of
22		the	contract, including an explanation of the

1		requirements of section 441-22.8, and a statement in
2		twelve-point bold type in substantially the following
3		form:
4		"YOU HAVE REFUND, CANCELLATION AND DEFAULT RIGHTS
5		UNDER STATE LAW AND UNDER THE CONTRACT. PLEASE READ
6		THE CONTRACT CAREFULLY FOR AN EXPLANATION OF THESE
7		RIGHTS";
8	(7)	The date and place of execution of the contract;
9	(8)	The cemetery or pre-need funeral authority's or its
10		duly authorized agent's signature on the contract and
11		the identification of this person by name and title;
12	(9)	A statement that the written contract, when signed,
13		shall constitute the entire agreement between the
14		parties relative to its subject matter and that all
15		obligations of both parties shall be fixed and
16		enforceable by the other parties of the contract;
17		[and]
18	(10)	A statement that the contract may not waive any rights
19		of the consumer or duties of the cemetery or pre-need
20		funeral authority under the law[-]; and
21	(11)	A statement in twelve-point bold type that complaints
22		concerning the cemetery or pre-need authority may be

1	filed with the department's regulated industries	
2	complaints office. The statement shall include the	
3	current address, telephone number, and electronic ma	ıi]
4	address for the regulated industries complaints	
5	office.	
6	(c) No mortuary, cemetery, or pre-need funeral authority	7
7	shall charge a price for the cemetery property, interment, or	
8	funeral services, whether it be at-need or pre-need, which is	
9	greater than the price on the itemized price list or contract	
10	which the purchaser had signed, unless the purchaser or the	
11	purchaser's authorized representative requests an additional	
12	item, the authority discloses the price for the additional ite	∍m ,
13	and the purchaser or its authorized representative approves the	ıe
14	price for the additional item. The mortuary, cemetery, or pre	<u> </u>
15	need funeral authority may charge the higher price for the	
16	additional item but shall collect in payment only that sum whi	.cl
17	is the difference between the higher price and the price liste	∍d
18	on the itemized price list or contract which the purchaser had	ł
19	previously signed.	
20	(d) At the time the services or merchandise are provided	<u>1</u>
21	under the terms of the contract, the cemetery or pre-need	
22	authority shall also provide a written notice to the person

- 1 requesting the services or merchandise of that person's right to
- 2 file a complaint with the department's regulated industries
- 3 complaints office. The written notice shall include the current
- 4 address, telephone number, and electronic mail address for the
- 5 regulated industries complaints office."
- 6 SECTION 2. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.

8 SECTION 3. This Act shall take effect on August 15, 2012.

Requires a mortuary, cemetery, or other such funeral authority to provide the current address, telephone number, and electronic mail address for the regulated industries complaints office in the disclosures of the written contract and in a written notice provided at the time that merchandise or services are delivered.
