A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
THIRD SENATORIAL DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$60,000,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary, is appropriated for fiscal year 2012-2013,
5 for the purpose of capital improvement projects for the third
6 senatorial district, as follows:

7 1. Expansion and improvements for area
8 hospitals and clinics.

9 A. Kona Hospital

10 Construct, renovate, and improve
11 fire sprinkler system, emergency
12 power heating and ventilation
13 system (HVAC), elevator upgrades,
14 facility master plan, roofs,
15 emergency room expansion, traffic
16 signal and intersection

1 made; provided that all moneys from the appropriations that are
2 unencumbered as of June 30, 2014, shall lapse as of that date.

3 SECTION 3. The sums appropriated for the respective
4 capital projects set forth in section 1 shall be expended for
5 the purposes of this Act as follows:

6 (1) The sums appropriated in items 1 and 7 shall be
7 expended by the department of accounting and general
8 services;

9 (2) The sums appropriated in items 2 and 6 shall be
10 expended by the department of education;

11 (3) The sum appropriated in item 3 shall be expended by
12 the department of land and natural resources;

13 (4) The sum appropriated in item 4 shall be expended by
14 the University of Hawaii; and

15 (5) The sum appropriated in item 5 shall be expended by
16 the department of transportation.

17 SECTION 4. This Act shall take effect on July 1, 2012.
