The purpose of this measure is to limit the fees that the  
Department of Land and Natural Resources may charge related to its  
comprehensive historic preservation program to amounts sufficient  
to cover the annual operating costs of the program, taking into  
account all other sources of program income.

The Department of Land and Natural Resources testified in  
support of this measure. The Society for Hawaiian Archaeology  
provided comments on this measure.


Your Committees have amended this measure by changing the  
effective date to July 1, 2020, for the purpose of facilitating  
future discussion.


Your Committees note that this measure is not intended to


