The Healthcare Association of Hawaii, Hawaii Primary Care Association, Waianae Coast Comprehensive Health Center, Hoola Lahui Hawaii, Lanai Community Health Center, Kalihi-Palama Health Center, Waikiki Health Center, Waimanalo Health Center, Kokua Kalihi Valley, West Hawaii Community Health Center, and two individuals testified in support of this measure. The Department of Health testified in support of the intent of this measure.

Your Committee recognizes that there is a growing number of uninsured in Hawaii and this is an issue that needs to be addressed. The uninsured are more costly to the State than providing basic coverage. Providing funding to community health centers, which serve many of the uninsured, will keep communities healthy and reduce state costs.
