Sir:

Your Committee on Labor & Public Employment, to which was referred H.B. No. 2584 entitled:

"A BILL FOR AN ACT RELATING TO NOTICE OF WORKERS'
COMPENSATION INSURANCE,"

begs leave to report as follows:

The purpose of this measure is to improve the effectiveness and efficiency of government by allowing the Director of Labor and Industrial Relations to accept the notice of employers' worker's compensation insurance from third party agencies that have been approved in a manner and form approved by the Director.

The Department of Labor and Industrial Relations, ILWU Local 142, and Hawaii Laborers' Union testified in support of this measure.

Currently, all workers' compensation insurance coverage information is submitted to the Department of Labor and Industrial Relations on paper forms which are then manually inputted into the Department's information system. However, budget cuts over the past several years due to lagging economic conditions have resulted in staff reductions and reduced the Department's capabilities of inputting the insurance information data in a timely manner. This delay often renders the information system's data reports unreliable. To address this situation, the Department of Labor and Industrial Relations plans to accept insurance information electronically thus making the inputting of

data easier and eliminating the labor-intensive process currently being employed.

As affirmed by the record of votes of the members of your Committee on Labor & Public Employment that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 2584 and recommends that it pass Second Reading and be referred to the Committee on Economic Revitalization & Business.


