Kikala-Keokea homestead an additional period of ten years to
construct dwellings in order to comply with the terms of their
long-term land leases with the Department of Land and Natural
Resources.

Na Ohana O Kalapana, Mokupuni O Oahu, Sovereign Councils of
the Hawaiian Homelands Assembly, Nanakuli Hawaiian Homestead
Community Association, Waianae Kai Homestead Community
Association, Kewalo Hawaiian Homestead Community Association, and
many concerned individuals supported this measure. The Department
of Land and Natural Resources offered comments on the measure.

As affirmed by the record of votes of the members of your
Committee on Hawaiian Affairs that is attached to this report,
your Committee is in accord with the intent and purpose of H.B.
No. 2808 and recommends that it pass Second Reading and be
referred to the Committee on Water, Land, & Ocean Resources.
