Your Committee on Water, Land, & Ocean Resources, to which  
was referred H.B. No. 453 entitled:

"A BILL FOR AN ACT RELATING TO PUBLIC ACCESS,"

begs leave to report as follows:

The purpose of this bill is to clarify that where public  
access is required as a condition of a subdivision:

- (1) If the county accepts the dedication, the county may  
require the subdivider to establish a stewardship fund  
to be controlled by the county for maintenance of the  
right of way; or
- (2) The county may require the subdivider or the planned  
community association to improve and maintain the right-  
of-way.


The Department of Land and Natural Resources provided


