Your Committee on Transportation, to which was referred  
H.C.R. No. 107 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE CREATION OF AN  
EXPLORATORY COMMITTEE TO CONSIDER THE ESTABLISHMENT OF AN  
INTERNATIONAL AVIATION TRAINING CENTER AT THE HILO  
INTERNATIONAL AIRPORT AND AN ADVANCED AVIATION DEGREE  
TRAINING PROGRAM AT THE UNIVERSITY OF HAWAII AT HILO,"

begs leave to report as follows:

The purpose of this measure is to request the Governor to  
convene an exploratory committee to consider the establishment of  
an international aviation training center at the Hilo  
International Airport and an advanced aviation degree training  
program at the University of Hawaii at Hilo.


The Department of Transportation and the University of Hawaii  
at Hilo supported the intent. One individual supported the  
resolution.

The demand for pilots is expected to soar with Boeing  
forecasting the need for over 27,000 new pilots a year and if  
military cutbacks occur we could see the traditional supply of  
trained pilots diminishing. The Hilo International Airport is an  
ideal venue as it is less busy than other airports providing a  
safer training environment as well as being in close proximity to  
the UH Hilo campus.



As affirmed by the record of votes of the members of your Committee on Transportation that is attached to this report, your Committee concurs with the intent and purpose of H.C.R. No. 107 and recommends that it be referred to the Committee on Higher Education.
