FACILITIES BY THE DIVISION OF BOATING AND OCEAN RECREATION OF
THE DEPARTMENT OF LAND AND NATURAL RESOURCES,"

begs leave to report as follows:

The purpose of this measure is to request that the Auditor
conduct a follow-up audit of the management of state boating
facilities, particularly with regards to the Ala Wai Small Boat
Harbor.

Numerous concerned individuals supported this measure. The
Department of Land and Natural Resources and several individuals
commented on this measure.


Your Committee notes that the Division of Boating and Ocean
Recreation of the Department of Land and Natural Resources has
testified that it is still in the process of implementing the
recommendations of the 1993, 1998, and 2001 legislative audits as
well as the 2006 legislative financial audit. Statewide, the
Division of Boating and Ocean Recreation has completed over
\$113,000,000 in capital improvement projects since 2001. With
regard to the Ala Wai Small Boat Harbor, the Division of Boating
and Ocean Recreation has completed over \$7,000,000 in capital
improvement projects and renovated or replaced over 60 percent of
all slips at the harbor within the past ten years.


