Your Committees on Health and Human Services, to which was referred H.R. No. 22 entitled:

"HOUSE RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH AND DEPARTMENT OF HUMAN SERVICES TO EDUCATE OPERATORS OF ADULT RESIDENTIAL CARE HOMES AND COMMUNITY CARE FOSTER HOMES ABOUT THE APPROPRIATE INSURANCE FOR THEIR BUSINESS,"

The purpose of this measure is to request the Department of Health and the Department of Human Services to:


