The purpose of this measure is to urge the Department of Land
and Natural Resources to review the natural resources marine
management rules, conduct public hearings on the rules, consult
with the Native Hawaiian people, and determine the relevance and
applicability of the rules to place-based management for purposes
of enhancing voluntary compliance and public participation in
marine resource management.


The Association of Hawaiian Civic Clubs and several concerned
individuals supported the measure.

As affirmed by the record of votes of the members of your
Committee on Hawaiian Affairs that is attached to this report,
your Committee concurs with the intent and purpose of H.R. No. 62
and recommends that it be referred to the Committee on Water,
Land, & Ocean Resources.


