Your Committee on Higher Education, to which was referred
S.B. No. 2005, S.D. 2, entitled:

"A BILL FOR AN ACT PROPOSING A CONSTITUTIONAL AMENDMENT TO
ARTICLE X, SECTION 6, OF THE HAWAII STATE CONSTITUTION TO
MODIFY THE APPOINTMENT PROCESS FOR THE BOARD OF REGENTS OF
THE UNIVERSITY OF HAWAII,"

begs leave to report as follows:

The purpose of this measure is to propose an amendment to
Article X, Section 6 of the Hawaii Constitution to remove the
requirement that the Governor nominate candidates for the
University of Hawaii Board of Regents from pools of qualified
candidates submitted by the Regents Candidate Advisory Council.

The Governor and University of Hawaii Professional Assembly
supported this measure. The Regents Candidate Advisory Council
and two concerned individuals opposed this measure.

As affirmed by the record of votes of the members of your
Committee on Higher Education that is attached to this report,
your Committee is in accord with the intent and purpose of S.B.
No. 2005, S.D. 2, and recommends that it pass Second Reading and
be referred to the Committee on Judiciary.


