The purpose and intent of this measure is to appropriate
funds for the comprehensive breast and cervical cancer control
program.

Your Committee received testimony in support of this measure
from HMSA, Planned Parenthood of Hawaii, and the American Cancer
Society Hawaii Pacific, Inc. You Committee received comments from
the Department of Human Services.

Your Committee finds that the comprehensive breast and
cervical cancer control program screens over a thousand people
every year and that the early detection and treatment of breast
and cervical cancer can lead to lower costs for overall treatment
as well as an increased likelihood for a positive treatment
outcome.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee is in accord with the intent and purpose of S.B.
No. 2572 and recommends that it pass Second Reading and be
referred to the Committee on Ways and Means.
