and Medicare.


Your Committee finds that the Department of Human Services
has already begun working with the Centers for Medicare and
Medicaid Services on a demonstration dual integration project that
includes Centers-approved dual eligible special needs plans. Your
Committee also finds that integrating the management of Medicare
and Medicaid health services has the potential to decrease costs
and increase the quality of health care by closing coverage gaps,
decreasing fragmented care, and streamlining the administrative
process.

S.D. 1, and recommends its adoption.


