begs leave to report as follows:

The purpose of this measure is to urge the Kaho'olawe Island Reserve Commission to require each stewardship program conducting activities on the Kaho'olawe Island Reserve to obtain liability and property damage insurance and list the State as an additional insured.

The Maui County representative of the Kaho'olawe Island Reserve Commission and a concerned individual supported the measure. Kohe Mälamalama O Kanaloa/Protect Kaho'olawe Fund supported the measure with amendments.

Your Committee respectfully notes that as this measure moves through the legislative process to the Committee on Finance that the committee be aware of a proposed amendment to this measure to provide the correct date of an accident involving a Protect Kaho'olawe Ohana access participant and clarify that the boat was not contracted, but was rather provided by a volunteer of the

Protect Kaho'olawe Ohana and that this boat was registered with the Kaho'olawe Island Reserve Commission.
