begs leave to report as follows:

The purpose and intent of this measure is to approve the sale  
of the leased fee interest in 41-557 Kamanaaina Place, Waimanalo,  
Hawaii, to its current leasehold owner.

Your Committee received written comments in support of this  
measure from the Hawaii Housing Finance and Development  
Corporation and the Department of Business, Economic Development,  
and Tourism. The Office of Hawaiian Affairs submitted written  
comments on the measure.

Your Committee finds that the Hawaii Housing Finance and  
Development Corporation desires to sell the leased fee interest in  
41-557 Kamanaaina Place, Waimanalo, Hawaii, which is a single  
family home that is part of the Waimanalo Village Annex Self Help  
affordable housing project. This measure satisfies the  
requirement of section 171-64.7, Hawaii Revised Statutes, that the  
Legislature provide approval by concurrent resolution prior to the  
sale of certain state lands in fee simple.


