Your Committee on Ways and Means, to which was referred  
S.C.R. No. 23 entitled:

"SENATE CONCURRENT RESOLUTION APPROVING THE SALE OF THE  
LEASED FEE INTEREST IN 2949 ALA ILIMA STREET, NO. 303,  
HONOLULU, HAWAII,"

begs leave to report as follows:

The purpose and intent of this measure is to approve the sale  
of the leased fee interest in 2949 Ala Ilima Street, No. 303,  
Honolulu, Hawaii, to its current leasehold owners.

Your Committee received written comments in support of this  
measure from the Hawaii Housing Finance and Development  
Corporation and the Department of Business, Economic Development,  
and Tourism. The Office of Hawaiian Affairs submitted written  
comments on the measure.

Your Committee finds that the Hawaii Housing Finance and  
Development Corporation desires to sell the leased fee interest in  
2949 Ala Ilima Street, No. 303, Honolulu, Hawaii, which is an  
apartment unit in the Puana Malu condominium. This measure  
satisfies the requirement of section 171-64.7, Hawaii Revised  
Statutes, that the Legislature provide approval by concurrent  
resolution prior to the sale of certain state lands in fee simple.

As affirmed by the record of votes of the members of your  
Committee on Ways and Means that is attached to this report, your  
Committee concurs with the intent and purpose of S.C.R. No. 23 and  
recommends its adoption.
