satisfies the requirement of section 171-64.7, Hawaii Revised
Statutes, that the Legislature provide approval by concurrent
resolution prior to the sale of certain state lands in fee simple.

Committee concurs with the intent and purpose of S.C.R. No. 25 and
recommends its adoption.
