Your Committee on Ways and Means, to which was referred
S.C.R. No. 56, S.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF
LAND AND NATURAL RESOURCES TO DEVELOP RECOMMENDATIONS FOR
INCREASED FEES TO HELP SUPPORT A FULLY STAFFED STATE HISTORIC
PRESERVATION DIVISION PROGRAM,"

begs leave to report as follows:

The purpose and intent of this measure is to request the
Department of Land and Natural Resources to develop
recommendations for increased fees to help support a fully staffed
State Historic Preservation Division program.

Additionally, the measure requests the Department of Land and
Natural Resources to pursue its recommended fee increases to
partially defray the costs of regulating archaeological activities
and reviewing proposed projects that may affect historic property,
aviation artifacts, or burial sites, through amendments to rules
adopted pursuant to chapter 91, Hawaii Revised Statutes.

Your Committee finds that, in recent years, the State
Historic Preservation Division has faced a growing workload while
dealing with reductions in personnel and budget cuts. Increasing
the fees for archaeological permits and historic preservation
reviews will help support a fully staffed State Historic
Preservation Division program. Your Committee believes that the
data requested by this measure will allow the State to determine
fee increases that are realistic but not prohibitive.


