CORPORATION TO ACQUIRE LAND FOR IMPROVEMENTS TO ITS  
INFRASTRUCTURE NECESSARY TO ACHIEVE ITS MISSION,"

beg leave to report as follows:

The purpose and intent of this measure is to request the  
Agribusiness Development Corporation to acquire land for  
improvements to its infrastructure that are necessary for the  
Agribusiness Development Corporation to achieve its mission.

Your Committees received testimony in support of this measure  
from the Agribusiness Development Corporation and Hawaii Farm  
Bureau Federation.

Your Committees find that the Agribusiness Development  
Corporation lacks the necessary infrastructure to fulfill its core  
mission, including assisting farmers and ranchers by providing  
adequate storage facilities for their goods. This measure  
requests the Agribusiness Development Corporation to explore the  
feasibility of acquiring certain land in Wahiawa and using that  
land to enhance the economic viability of the agricultural  
community.


Your Committees have amended this measure by making


