SB 2429 RELATING TO FORECLOSURES. CPN, JDL Implements the 2011 recommendations of the mortgage Status & foreclosure task force to address various issues relating to the **Testimony** mortgage foreclosures law and related issues affecting homeowner association liens and the collection of unpaid assessments. RELATING TO MORTGAGE FORECLOSURES. **SB 2428** CPN, JDL Repeals part I of chapter 667, HRS, relating to foreclosure by Status & action or foreclosure by power of sale. **Testimony SB 2442** RELATING TO COLLECTION REMEDIES FOR CPN, JDL ASSOCIATIONS. Status & Establishes an alternate power of sale process for condominium **Testimony** and planned community associations. Revises provisions on condominium liens for unpaid assessments and establishes similar provisions for planned community associations. Specifies the jurisdiction of the circuit courts over actions to foreclose association liens. RELATING TO MORTGAGE LOAN ORIGINATION. **SB 2763** CPN, WAM Amends the Secure and Fair Enforcement for Mortgage Status & Licensing Act to reflect recent federal changes and adjust fees Testimony in consideration of the new regulatory requirements. RELATING TO MORTGAGE SERVICERS. **SB 2764** CPN, WAM Requires every mortgage servicer who provides loan Status & modification services that would require licensure as a mortgage **Testimony** loan originator to be licensed as a mortgage loan originator in addition to being licensed as a mortgage servicer. RELATING TO PRIVATE TRANSFER FEES. **SB 2184** CPN, JDL Makes permanent the prohibition of private fees for a future Status & transfer of real property.
