<u>HB 2023</u> <u>(HSCR821-12)</u> <u>Status & Testimony</u>	RELATING TO THE CENTER FOR NURSING. Makes permanent the assessment and deposit of center for nursing fees into the compliance resolution fund and distribution of those funds to the credit of the center for nursing special fund.	CPN, WAM
<u>HB 2644, HD2</u> <u>(HSCR947-12)</u> <u>Status & Testimony</u>	RELATING TO THE PUBLIC UTILITIES COMMISSION. Requires the Public Utilities Commission to implement best practices in the areas of regulatory frameworks, rules and procedures, and information technology and public access. Appropriates funds to implement best practices. Effective July 1, 2030. (HB2644 HD2)	CPN, WAM
<u>HB 2162, HD1</u> <u>(HSCR847-12)</u> <u>Status & Testimony</u>	RELATING TO UNIFORM COMMERCIAL CODE ARTICLE 9. Implements the amendments to Article 9 of the Uniform Commercial Code, relating to secured transactions, set forth by the Uniform Law Commission. Effective July 1, 2013. (HB2162 HD1)	CPN, JDL
