<u>HB 2519</u> <u>Status</u>	RELATED TO EARLY LEARNING. Appropriates funds to the Department of Education to support early childhood education.	EDN/HUS, FIN
<u>HB 2091</u> <u>Status</u>	RELATING TO EDUCATION. Directs the Department of Education to establish a three-year pilot project that implements a comprehensive assessment program for certain students in grades seven, eight, and nine.	EDN, FIN
<u>HB 2728</u> <u>Status</u>	RELATING TO EARLY LEARNING. Requires the department of taxation to allow a taxpayer to designate (or "check off") that a specified amount of the taxpayer's income tax refund be paid to the early learning trust fund.	EDN, FIN
<u>HB 1683</u> <u>Status</u>	RELATING TO JUNIOR KINDERGARTEN. Eliminates junior kindergarten beginning with the 2014-2015 school year. Effective July 1, 2014.	EDN, FIN

- The date and time of the hearing;
- Measure number; and
- The number of copies the Committee is requesting.

While every effort will be made to copy, organize, and collate all testimony received, materials received on the day of the hearing or improperly identified or directed to the incorrect office, may be distributed to the Committee after the hearing.

Submit testimony in ONE of the following ways:


