<a href="#">SB 1197, SD2</a> <a href="#">(SSCR533)</a> <a href="#">Status</a>	RELATING TO ENERGY. Requires the incorporation to the fullest extent possible of alternative energy designs into construction of, and major renovations to, schools and state facilities for which planning begins after 6/30/13. Effective 7/1/50. (SD2)	EEP, EDN, FIN
<a href="#">SB 656, SD1</a> <a href="#">(SSCR54)</a> <a href="#">Status</a>	RELATING TO THE PUBLIC UTILITIES COMMISSION. Requires the public utilities commission to publish contracts, including price information, for the purchase of renewable energy by energy utilities on a publicly-accessible portion of the commission's website. (SD1)	EEP, CPC/JUD, FIN
<a href="#">SB 2981, SD2</a> <a href="#">(SSCR2679)</a> <a href="#">Status</a>	RELATING TO RENEWABLE ENERGY. Allows the public utilities commission to direct electric utilities to develop or consider specific scenarios and resource options as part of their integrated resource plans. (SD2)	EEP, CPC, FIN
