
<u>HB 1886</u> <u>Status</u>	RELATING TO CHILD SAFETY. Makes it a class C felony for parents, guardians, and custodians of a child to fail to report the disappearance or death of the child to the Department of Human Services or the police department within hours. Makes it a class C felony for family members to fail to report known child abuse or neglect to the Department of Human Services or police department within hours.	HUS/HLT, JUD
<u>HB 2792</u> <u>Status</u>	RELATING TO MEDICAID. Authorizes the Department of Human Services to provide medical assistance for dialysis, chemotherapy, and other cancer treatments, inpatient and outpatient physician visits, and drug prescriptions. Effective July 1, 2012.	HUS/HLT, FIN


