The purpose of this informational briefing is to discuss questions, concerns, and/or comments regarding the following bills:

~~Requires applicants and recipients of Temporary Assistance for Needy Families cash benefits to submit to drug testing when reasonable cause exists indicating illegal drug use. Establishes ineligibility to receive benefits for one year for testing positive or refusing to submit to drug testing~~

~~RELATING TO TEMPORARY ASSISTANCE FOR NEEDY FAMILIES.~~

~~Temporary Assistance for Needy Families: Drug Screening~~

~~Requires drug testing for temporary assistance for needy families (TANF) applicants. Provides that applicants who test positive for a controlled substance may receive TANF funds upon the successful completion of a 6-month substance abuse program~~

Specifically, this informational briefing will answer some of the high profile questions and concerns about these measures such as:

Do these measures violate the U.S. Constitution's 4th Amendment right of unreasonable searches and seizures of the individual?

Private employers are allowed to drug test prospective employees. Does this mean the government should be allowed to drug test welfare recipients or applicants?

Is there a relevant connection between TANF recipients and illegal drug use?

Are these measures unreasonably targeting or stereotyping TANF (public assistant) recipients and applicants?

Finally, at the conclusion of this informational briefing, the Chair will summarize the relevant arguments for and against these two measures.




