Requires the Department of Public Safety to plan for a model wellness center that employs native Hawaiian cultural practices on state land and to submit a report to the legislature prior to the 2013 legislative session. <a href="#">SB2212</a> <a href="#">Status and Testimony</a>	RELATING TO HAWAIIAN HOMES COMMISSION ACT, 1920, AS AMENDED. Repeals the congressional consent requirement for amendments made to the provision relating to community based governance on Hawaiian home lands.	HWN/PGM, JDL
<a href="#">SB2639</a> <a href="#">Status and Testimony</a>	RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS. Requires DHHL to develop and administer an off-the-grid living program to place eligible native Hawaiians on DHHL land prior to installation of utility infrastructure provided that federal and basic habitation requirements are met. <a href="#">SB2457</a> <a href="#">Status and Testimony</a>	RELATING TO PROCUREMENT. <u>Requires a hearing officer to affirm the decision of a procurement officer in protests filed under section 103D-701, HRS, unless the procurement officer's decision is shown by clear and convincing evidence to be arbitrary, capricious, fraudulent, or clearly erroneous.</u>	PGM, JDL [Measure added on 2/14/2012]

RELATING TO FIREARMS.

Restricts hunting to areas on public land where hunting is permitted or to areas on private land where the landowner has granted written permission. Allows transport and possession of firearms and ammunition in areas where hunting is permitted. Effective July 1, 2012.
