<a href="#"><u>SB 2346</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO TAXATION. Effective 1/1/13, increases the vehicle weight tax and repeals the state portion of the fuel tax.	WAM
<a href="#"><u>SB 2948</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO FINANCING AGREEMENTS. Specifies that the issuance of certificates of participation does not require legislative approval.	WAM
<a href="#"><u>SB 2988</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO STATE FUNDS. Authorizes the director of finance to restructure the debt service for state obligations; provided that any such restructuring shall take into consideration the long-term financial obligations of the State and shall not be undertaken solely to provide short-term savings.	WAM
<a href="#"><u>SB 2819</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO SALES OF ELECTRONIC CIGARETTES. Places e-cigarettes with other tobacco products as items prohibited to be sold to a minor and amends the definition of "tobacco products" for purposes of taxation.	WAM
