Effective retroactive to July 1, 2011. (HB2495 HD1)

RELATING TO THE STATE PROCUREMENT CODE.

Makes permanent the amendments made to section 103D-305, Hawaii Revised Statutes, that increase the limits on procurements qualifying for certain small purchase procedures to \$100,000 for goods or services and \$250,000 for construction; require procurements greater than \$50,000 for construction to require performance bonds; and require procurements of \$25,000 to less than \$100,000 to be made in accordance with small purchase procedures. Effective July 1, 2050. (SD1)
