

### FORTY-FOURTH DAY

**Wednesday, April 04, 2012**

The House of Representatives of the Twenty-Sixth Legislature of the State of Hawaii, Regular Session of 2012, convened at 12:05 o'clock p.m., with Speaker Say presiding.

The invocation was delivered by Mr. John Foster of Representative Roy Takumi's office, after which the Roll was called showing all Members present with the exception of Representatives Carroll, Hanohano, Mizuno, Thielen and Wooley, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Forty-Third Day was deferred.

Representative Aquino, for the Committee on Public Safety & Military Affairs presented a report (Stand. Com. Rep. No. 1510-12) recommending that S.B. No. 2909, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Chong, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 2909, entitled: "A BILL FOR AN ACT RELATING TO ENHANCED 911 SERVICES," passed Second Reading and was placed on the calendar for

Third Reading, with Representatives Carroll, Hanohano, Keith-Agaran and Thielen being excused.

Representatives Herkes and Keith-Agaran, for the Committee on Consumer Protection & Commerce and the Committee on Judiciary presented a report (Stand. Com. Rep. No. 1511-12) recommending that S.B. No. 3002, SD 2, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Chong moved that the report of the Committees be adopted, and that S.B. No. 3002, SD 2, HD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and S.B. No. 3002, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO REAL ESTATE BROKERS AND SALESPERSONS," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Carroll, Hanohano, Keith-Agaran and Thielen being excused.

Representative Herkes, for the Committee on Consumer Protection & Commerce presented a report (Stand. Com. Rep. No. 1512-12) recommending that H.R. No. 138, be adopted.

Representative Chong moved that the report of the Committee be adopted, and that H.R. No. 138, be adopted, seconded by Representative Evans.

Representative McKelvey rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative McKelvey's written remarks are as follows:

"Tesoro oil refinery recently announced its sale during a time of positive, yet fragile, economic growth within the State. This announcement has caused a great deal of concern regarding the economic impact on consumers and the State. The sale, or inability to sell, has also raised the concern of Tesoro's employees and their job security.

"While this complex sales transaction unfolds, it is imperative that the Legislature understand the economic effects of the sale on the financial well being of consumers and the State. The Legislature should be prepared to take all necessary steps to ensure that consumers are protected from skyrocketing oil prices that would threaten to cripple our slowly recovering local economy. Therefore, I support House Resolution 138 requesting that the Speaker of the House of Representatives convene a legislative task force to assess the impact of the potential sale of the Tesoro oil refinery on consumers and the State.

"The *kuleana* of the appointed task force will be to develop economic models that illustrate the potential economic effect that having a single refinery operating in the State would have as compared to having at least two refineries operating in the State. Furthermore, the task force will develop an economic model that considers the financial impact to Hawaii consumers and the State if a natural or man-made event causes an oil refinery in the State to temporarily cease production; how petroleum products could be supplied under such a scenario; and the projected impact of such a scenario. The creation of this task force will provide a venue where Tesoro can possibly share their *mana'o* of the marketplace and describe hurdles that the local petroleum industry faces in doing business in Hawaii.

"As energy challenges have become increasingly likely due to shrinking oil reserves and increasing energy use the insights gained by the task force will prove to be a valuable resource in the States response to oil shortages. Only by developing a greater understanding of our oil industry can we create the tools necessary to facilitate the creation of a coherent and integrated energy plan."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.R. No. 138, entitled: "HOUSE RESOLUTION REQUESTING THE SPEAKER OF THE HOUSE OF REPRESENTATIVES TO CONVENE A LEGISLATIVE TASK FORCE TO ASSESS THE IMPACT OF THE POTENTIAL SALE OF THE TESORO OIL REFINERY ON CONSUMERS AND THE STATE," was adopted, with Representatives Carroll, Hanohano and Thielen being excused.

Representative Chang, for the Committee on Water, Land, & Ocean Resources presented two reports:

(Stand. Com. Rep. No. 1513-12) recommending that H.R. No. 41, be adopted; and

(Stand. Com. Rep. No. 1514-12) recommending that H.C.R. No. 61, be adopted.

Representative Chong moved that the reports of the Committee be adopted, and that H.R. No. 41; and H.C.R. No. 61, be adopted, seconded by Representative Evans.

Representative Riviere rose to speak in support of both measures with reservations, stating:

"Mr. Speaker. Can we go back to the measures on the cowry shell, if I may? That was Stand. Com. Rep. Nos. 1513 and 1514. I just wanted to note some reservations there. It's good that we're doing this, but I think we might have been better off choosing a seashell unique to Hawaii. Thank you."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 41, entitled: "HOUSE RESOLUTION IN SUPPORT OF DECLARING THE SERPENT'S HEAD COWRY SHELL AS THE HAWAII STATE SEA SHELL," was adopted, with Representatives Carroll, Hanohano and Thielen being excused; and

Representative Chang, for the Committee on Water, Land, & Ocean Resources presented two reports:

Representative Chong moved that the reports of the Committee be adopted, and that H.R. No. 126; and H.C.R. No. 162, be adopted, seconded by Representative Evans.

Representative Har rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. In strong support of these very important Resolutions on behalf of Spreckelsville Beach Lots."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 126, entitled: "HOUSE RESOLUTION AUTHORIZING THE GRANT OF A FIFTY-FIVE YEAR TERM FOR A NON-EXCLUSIVE EASEMENT TO KOOLAU PROPERTIES, LLC, FOR SEAWALL PURPOSES AT SPRECKLESVILLE BEACH LOTS, WAILUKU, MAUI, AS APPROVED BY THE BOARD OF LAND AND NATURAL RESOURCES," was adopted, with Representatives Carroll, Hanohano and Thielen being excused; and

Representative Keith-Agaran, for the Committee on Judiciary presented a report (Stand. Com. Rep. No. 1517-12) recommending that H.C.R. No. 84, as amended in HD 1, be adopted.

Representative Chong moved that the report of the Committee be adopted, and that H.C.R. No. 84, HD 1, be adopted, seconded by Representative Evans.

Representative Ching rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I just rise with very slight reservations on Stand. Com. Rep. 1517. I know that it says here that they will be able to, the hunters, I'm speaking of, work with the farm owners to be able to control the pigs and to be able to get permission. But it's my understanding from speaking with just some hunters that sometimes there's a reluctance of the landowners to *per se*, get in. You know, it's a little bit time consuming or what have you, to go get the paper. And so it might actually result in less hunting of pigs.

"As an environmental concern, I think people should. I'm sure this Chamber is well aware of the damaging effects of pigs. And in my valley, Nuuanu Valley that I share with the Representative from Nuuanu, we have a pig problem. And you know we want to make sure we're doing everything we can to win-win. Make sure that the landowners are not put in any kind of liability, but that pig hunters can hunt pig.

"We've actually, just as an amusing fact, have had a pig come all the way down to Bachelot Street. Thank you."

Representative Cabanilla rose to speak in support of the measure with reservations, stating:

"I also want to speak with reservations on this measure. I think this Stand. Com. or HCR No. 84 will be very difficult to enforce. Because when you're hunting out there in the open, and you're chasing a wild animal, you may not know where the boundaries are. Or you're just so engulfed in your activity, that the boundaries may not be your priority. I would hate for people to get caught with this enforcement of law, should a law be written as a result of this Resolution. Thank you, Mr. Speaker."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.C.R. No. 84, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION URGING THE ADOPTION OF LAWS TO REQUIRE WRITTEN PERMISSION FROM THE LANDOWNER IN ORDER TO HUNT ON PRIVATE LANDS," was adopted, with Representatives Carroll, Hanohano and Thielen being excused.

Representative Keith-Agaran, for the Committee on Judiciary presented a report (Stand. Com. Rep. No. 1518-12) recommending that H.R. No. 119, as amended in HD 1, be adopted.

Representative Ward: "Mr. Speaker, today's floor presentation was very revealing. We learned about Marilyn the Majorette, Karen Awana the Cheerleader, and at the recess, I learned that Cindy Evans was also a cheerleader. She asked a question which I would ask as an announcement. How many other cheerleaders have we in this group? Representative Choy? No.

"Okay, that was inspiring, because the question that also arose was, how many played football, such as myself who was the co-captain, who benefitted from the *esprit de corps*? Because the Finance Committee, until 2:00 a.m. last night, the *esprit de corps* is very, very important.

"So how many did organized sports, either in high school, or college? So today was very inspiring, Mr. Speaker, and hopefully the *esprit de corps* will continue until the end of this Session when *sine die* is coming. Thank you.

"And lastly, there's a fellowship luncheon. And in fact this is supposed to be Ty and Derrick's day because they're providing lunch in Room 437. The fellowship luncheon, as we dismiss. Thank you, Mr. Speaker."

Representative Belatti: "Mr. Speaker, I know there's a lot going on this afternoon, but if Members want to stop by, the Maryknoll delegation is going to be in Room 329 with a light lunch. If you want to stop by and take pictures, please join us. Thank you."
