"From my experience, the people embrace the same type of welcoming spirit known to us as *aloha*. Over many centuries, Turkey has experienced many people from all parts of the world. By building these positive relations with countries such as Istanbul, Turkey, Hawaii will help to seed the *aloha* spirit and bridge the friendships that will last for generations to come. Thank you, Mr. Speaker."

Should this measure pass, there is an estimated increase of 280,000 visitors from foreign countries which would boost economic growth in the State. As stated in these Resolutions, it is estimated that the average visitor from China would stay in the State for six days and spend \$350 a day, yielding an estimated \$573,000,000 for Hawaii's economy. Mr. Speaker, with the passage of these Resolutions, this legislative body would be supporting economic growth at a time when most needed, as well as looking beyond the Party borders and do what is best for the people of our State. Thank you, Mr. Speaker."
