SB2228, SD2, HD1	RELATING TO PSEUDOEPHEDRINE. Establishes an electronic tracking system for the sale of products containing pseudoephedrine. Limits the amount of pseudoephedrine products that may be sold or distributed to a person without a prescription to not more than 3.6 grams per day or not more than nine grams per 30-day period. Requires the pharmacy or retailer to maintain a written or electronic log of nonprescription products containing pseudoephedrine sold. (SB2228 HD1)	HLT, JUD
SB2893, SD1	RELATING TO GAMBLING. Establishes a nine-member gambling commission exempt from section 26-34, Hawaii Revised Statutes, attached to the office of the auditor, to undertake a comprehensive analysis of the social and economic costs and benefits of different forms of gambling and their impacts on the State in order for legislators to make informed policy decisions regarding gambling. Requires report to governor and legislature twenty days prior to the 2013 and 2014 legislative sessions. Commission sunsets 12/31/2013. Appropriates funds to undertake the analysis, including contracts for services. Effective 7/1/2050. (SD1)	FIN
