Ms. Oliveira Gray is a reliable member and has attended 6 of 9 meetings since her appointment. She is prepared for the meetings and participates in discussions.



Dear Chair Baker, Vice-Chair Taniguchi, and members of the Senate Committee on Commerce and Consumer Protection:

Thank you for this opportunity to speak with you today. I am seeking confirmation for my nomination as a public member on the Board of Pharmacy. I have a professional interest in the delivery of integrated, interdisciplinary care, as well as, that of public service. I wish to serve on the Board of Pharmacy to fulfill both these interests.

I have been a licensed psychologist in Hawai'i since 2001. On a professional level, I have been involved in the delivery of integrated, interdisciplinary care and improving the health status and well-being of underserved and/or disenfranchised populations. My work has afforded me excellent opportunities to work alongside other health care professionals from a wide range of specialities in rural areas where collaboration and joint decision-making are critical elements of patient care.

I have worked primarily in rural, medically underserved areas as a primary care psychologist in community health centers. I work collaboratively with physicians, nurses, medical assistants, nutritionists, community outreach workers, and medical case managers on a daily basis.
