### Brian Combs, Ph.D., ABPP Personal Statement

Why I want to be a member of the board of Psychology:

I believe that all psychologists should strive to promote the profession while at the same time protecting the interests of the general public and specifically the clients we serve. When I was contacted by a current member of the licensing board to volunteer, I considered it opportunity as well as an obligation to contribute to the regulated practice of clinical psychology in the State of Hawaii.

My understanding of the role and responsibilities of board members:

I understand that my role as a member of the board of psychology is to protect consumers and promote the public interest. To this end I understand that the board is tasked with promoting policies and actions that encourage healthy competition, have a minimal impact on cost, are neither too strict nor to lenient, and allow fair and reasonable entry into the profession. I also understand that it is paramount that the board ensures the competence of licensees.

The board has legislative, adjudicative, and executive duties. Besides reviewing applications and determining whether they should be granted the board also assists in the creation of laws governing the profession and resolves conflicts brought before the board. Why I believe I am qualified to serve on the board:

I have worked as a licensed clinical psychologist and the state of Hawaii for 20 years. I have been involved in leadership positions at the Queens Medical Center and the Rehabilitation Hospital of Pacific, serving as chief of psychology at both institutions and serving on various committees including the hospital Ethics Committee at Queens and the Medical Executive Committee at Rehab.
