

My perception is that CBED Advisory Council facilitates and encourages economic development through various projects within our communities that is in line with and respectful to both our residents and visitors. My role as a Maui County representative is to keep the best interest of the County, along with the State, in mind while embarking on new projects. I would also like to seek opportunities for networking with local businesses and/or agencies in Maui County. Networking for both learning and growth is important and contributes to strengthening our economy.

3. Given your understanding of the role and responsibilities of a member of the Community-Based Economic Development Advisory Council, why do you believe that you are qualified for the position? I feel that I am qualified based on my nearly 14 years of County government experience in the Office of Economic Development (OED) coupled with my experience in the private sector. While with the County's OED I was responsible for:

- grant writing (both State and Federal grants to leverage County funds)
- oversight of approximately 50 County funded grants
- oversight and implementation of Federal grants
- providing technical assistance to both grantees and sub-contractors and ensuring compliance as it relates to State or Federal regulations by granting agency
- working with various projects and/or initiatives with various industries (e.g. small business, film and entertainment, agriculture, workforce development, etc.)

By working the other Advisory Council members, I hope to accomplish a greater knowledge of the diversity of projects and opportunities that are available across the State and to be able to make a connection to Maui County agencies and/or businesses when possible. Ultimately promoting economic development in our communities.

Three qualities: team player, enthusiastic, open to challenges

My qualities would help to bring new energy to the Advisory Council and compliment the already existing composition.

6. Name one previous experience that would make you stand out. How would this benefit the Community-Based Economic Development Advisory Council?

Although there have been several notable project-based experiences, including obtaining a planning and design grant for the Wailuku Parking Structure, the one project-based experience that stands out is the establishment of the Na Koa Ikaika Maui Professional Baseball Team here in Maui. This project reflected in a more immediate economic impact on our community and involved both local government working with a new business to establish the Team here on Maui. Thereafter, the benefits were realized by local businesses, local non-profits, residents and visitors alike. The Team's schedule averaged 44 home games all played in Wailuku, Maui. Visiting teams came from Canada, Mexico and various areas across the United States. Each team along with their families, boosters, media and fans stayed an average of six (6) nights here on Maui. This exposure to Maui as a viable sports venue as well as a true vacation destination was priceless.

Na Koa Ikaika Maui is entering into their third season this year with opening day on Maui scheduled for June 5th.
