I am pleased to write this letter in strong support of Mr. David Langille's Governor's Message #572 to serve on the procurement board. David is a team player and is very willing to serve the public.


Mr. Langille and I met in 2006, when he joined the management team at Kahala Nui as the Director of Facilities.


My name is Ronald J. Schewe. This letter is submitted in strong support of GM 572 for Mr. David Langille to serve as a member of the Procurement Policy Board.
