Today, I have the privilege of serving the people of Maui County as the Commander of the Uniformed Services Bureau. Moloka'i Patrol District is just one of seven patrol district and section commands that make up said bureau.

(1) Why do you wish to be a member of the Enhanced 911 Board?

Being apart of said Board for the past five years have allowed me to work closely with other PSAP representatives and representative of various mobile companies. Although I don't have the technical knowledge that some members bring to the table, I do understand, as do all Board Members, that it is absolutely crucial that everyone dialing 9-1-1 can be identified and located so that their emergency needs can be addressed. In addition, it is very important that the monies collected from the surcharge is spent wisely to benefit the residents and visitors of Hawaii Nei.

(2) Given your understanding of the role and responsibilities of a member of the Wireless Enhanced 911 Board, why do I believe that you are qualified for the position?

I believe that my fives years of service with the Enhanced 911 Board will bring continuity of relationships already formed and reaching the goal of having interoperability between all Public Safety Answering Points.

(3) What do you hope to accomplish during your term of service?

To continue to represent Moloka'i Residents ensuring that their 9-1-1 calls continue to provide accurate identification and location information identification for emergency services.


