Thank you for your questions and the opportunity to respond to the following:

#### 1. A description of your experience in the field of Comptroller, or any related field.

I have ten years of legislative experience a staff member on the House Committee on Finance and Senate Committee on Ways and Means. Based on this experience, I fully understand the role of the legislature and am ready to execute the policies enacted by the legislature.

My experience in the Executive Branch includes, two years as a member of the Governor's research staff and twelve years of experience as a Planning and Policy Analyst in the Department of Accounting and General Services, Public Works Division. During this time, I was also the legislative coordinator for the Department of Accounting and General Services. I was also served as a deputy director to both the State Department of Taxation and the Department of Accounting and General Services.

As a deputy director and the legislative coordinator for the Department of Accounting and General Services, I have a good understanding of the issues affecting the department. I have worked very closely with four different comptrollers, and have learned from their successes and failures.

As you can see from my experiences in State government, especially within the Department of Accounting and General Services, I am fully aware of all the requirements of the Comptroller position and am ready to fulfill the duties and responsibilities effectively and immediately.

#### 2. An assessment of your strengths and weaknesses:

#### Strengths

- a. Highly motivated public servant with a strong work ethic
- b. Able to see the big picture and allow managers to run their operations

- c. Strong believer in customer service
- d. Supports dialogue and open communication
- e. Will always support staff
- f. Believe in face-to-face dialogue rather than email or telephone when possible
- g. I believe in creating and fostering a positive working atmosphere based on professionalism and a strong work ethic

#### Weaknesses

- a. Would prefer to deal with policy issues rather than small details
- b. Not very tolerant of long, disorganized meetings
- 3. An assessment of the department/agency strengths and weaknesses. Please include an explanation of how the department/agency's strengths may be best utilized, as well as how the department/agency's weaknesses may be improved.

Without doubt the department's strength lies in its employees. I have personally worked with many of DAGS' employees and have the utmost confidence and pride in knowing them. I call many of them my personal friends. They are hard working and knowledgeable about what they do. In the past, many of them have done more with less and they continue to do so. I believe that the employees that have weathered the "storm" have become seasoned veterans and are in a position to lead new employees which will result in the provision of better services for DAGS, other agencies, and the public.

However, doing more with less has reached a point where staff cannot maintain the same level of service without adequate staffing and resources. DAGS has suffered significant staffing reductions in the past two years and only recently has begun to rebuild its workforce. While we are still not close to previous high levels of staffing, each year we continue to rebuild and aggressively take action to fill vacancies.

4. An overall vision for the department/agency, specifically what goals can be accomplished within the next four years and what types of annual benchmarks can be used to evaluate the department/agency's progress towards those goals;

DAGS' mission is help State agencies better serve the public by providing, at best value with integrity: superior public facilities, expert technological solutions and services, operational support, fiscal guidance, oversight of administrative services, and preservation and promotion of cultural heritage.

Goals for the next four years:

a. Both the Governor and the Legislature are considering measures during this current Legislative Session which propose an aggressive construction package. Whichever proposal passes, it is my goal to implement these

projects appropriated to DAGS as quickly as possible. DAGS has done this before under the Cayetano administration's \$1 billion construction initiative and we can do it again. Benchmarks for this, after bills are enacted into law, would be nine months to complete the allotment process and another year to reach the construction phase.

- b. Renovate and restore the State's buildings that are unoccupied. Two examples of this are, the Kamamalu Building which has been empty for ten years and the Lihue Courthouse which has sat vacant for five years. My goal is to renovate buildings like these and relocate state employees currently in private leased space into these State buildings. Benchmarks will be to obtain funding for these projects in FY 2013 and occupy the buildings by the end of FY 2016.
- c. The State Capitol is one of the most significant buildings in the State of Hawaii. Unfortunately, things like the security system, fire alarm, and public address systems are starting to fail. My immediate goal is to have the security system fully functional by the end of 2012. A re-evaluation of the existing security, fire, and public address systems will be done and a funding request will be made for the 2013 legislative session. If funding is approved, the allotment request will be processed by FY 2014 and the construction phase started toward the latter half of FY 2014.

#### 5. The department/agencies top budgetary priority for the biennium;

The department's top budgetary priorities are as follows:

- a. Operating Budget
  - 1. CSD, AGS 231, request for utilities, submitted via Governor's message for \$4,769,000
  - 2. OIMT, Business Process and IT/IRM Reengineering, \$5,000,000
  - 3. OIMT, IT Integration Pilot Projects, \$1,825,000
  - 4. OIMT, IT Integration Pilot Projects, Digital Archives, \$175,000

#### CIP Budget

- 1. Kamamalu Building, design and construction for asbestos mitigation and renovation, \$17 million
- 2. Capitol Building, reseal and waterproof 5th floor roof deck; \$8 million
- 3. Lump sum advance planning-update of State Capital District Master Plan, \$1 million
- 4. Statewide Financial System Enterprise Reengineering (ERP), \$15 million
- 6. An assessment of the department/agency staff's morale, including the turnover rate for personnel.

My assessment is that DAGS' staff morale is good. In part, due to the restoration of positions and the filling of vacancies are definitely having a positive effect on staff morale.

There is minimal turnover at DAGS, but those that we lose to retirement take with them a significant amount of institutional knowledge.

7. Any foreseeable possible conflicts of interest that could arise during your service in the department and how you would overcome them.

At the moment I cannot think of any specific situation that would constitute a conflict of interest. However, as Comptroller, I do sit on a number of Boards and Commissions and should a conflict of interest arise I would recuse myself and assign someone to stand in for me on that particular issue.
