SUBJECT: GM 637 – State Council on Developmental Disabilities Gubernatorial Nominee Patricia Nishimoto

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 637** to confirm the nomination of Patricia Nishimoto for a term to expire June 30, 2016.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the players involved in the development, implementation, and use of DD supports are represented. The law specifically requires that 60 percent of the membership of the Council be comprised of individuals with DD, their parents, or family members. Additionally, the following are required to be on the Council: relevant State entities; State entities that administer funds provided under the Rehabilitation Act of 1973; the Individuals with Disabilities Education Act; the Older Americans Act of 1965; Titles V and XIX of the Social Security Act; the Protection and Advocacy Agency; the Centers for Excellence in DD Education, Research, and Service; local and non-governmental agencies, and private non-profit groups concerned with services for individuals with DD.

Dr. Nishimoto's reappointment to the Council would continue to fulfill the Federal requirement for representatives of local and non-governmental agencies. Dr. Nishimoto is the MSW Program Director, Assistant Professor of Social Work at Hawai'i Pacific University (HPU). She was first appointed to the Council in May 2006 and has remained an active Council member. Presently, she serves as Co-Chair of the Council's Community Supports Committee and previously served as Co-Chair of the Health and Early Childhood Committee. Under her leadership as Co-Chair of the Health and Early Childhood Committee, the Council made great strides in monitoring the implementation of the Quest Expanded Access Program and providing feedback to

the Department of Human Services on areas for improvement. The Community Supports Committee is engaged in activities to support individuals with DD to live self-determined lives.

Her previous experience as a Chief Executive Officer for a non-profit organization serving people with DD provided her with a wealth of knowledge and understanding of the need for qualified direct support personnel to provide services and supports for individuals with DD. Currently, as the MSW Program Director at HPU, Dr. Nishimoto would assist the Council to build capacity in the social work profession to work with individuals with DD and families.

We are pleased with Dr. Nishimoto's nomination to serve a second term on the Council and look forward to her continued contributions to the Council's State Plan activities.

Thank you for the opportunity to express our strong support for **GM 637** to confirm Patricia Nishimoto to the State Council on Developmental Disabilities.
